#### 38.19 Clerks Report

### 43.19 To consider the installation of Birds mouth fencing on the grass verge on Spalding Road to stop vehicles parking on it.

#### 44.19 To receive an update regarding the Welland Footbridge Project

Councillor Ward advised that he had been communicating with LCC to obtain the documentation needed to allow the right of way across the river however this had been delayed as there is a piece of land south of the river where ownership is not known - Peterborough City Council are dealing with this. A group called Sustrans are preparing the tender document requirements and the Footbridge group are investigating potential funders.

Councillor Ward confirmed that the move to two nights had been successful with 110 attendees in the month of June 2018 and the Youth Group had been nominated for the best charity award in this year's Deepings Business Club Awards. New Trustees were needed as the Chair and Secretary were resigning at the end of 2018. The accounts are being prepared and it was proposed seconded and **RESOLVED** that the second instalment should not be released until these were available.

### 46.19 To consider a request from a member of the public to remove or re-position the picnic bench on Jubilee Park

Councillor Bowell introduced this item as a parishioner had contacted him saying that after a number of incidences of anti-social behaviour occurring, many of which had been reported to the Police along with the volume of litter around it and condition of the bench he requested that the picnic bench was removed from its current location. It was proposed seconded and **RESOLVED** that the bench would not be removed as it was not responsible for the anti-social behaviour and the removal of it was detrimental to those who use it responsibly. This

decision would be kept under review. The Clerk was asked to inform the Parishioner of this and arrange for the cleaning and re-painting of the picnic bench and the continuance of the regular litter picks in the area.
