Minutes of the Deeping St James Parish Council meeting held on **Thursday 31 May 2018 at 7.30** pm at The Institute.

Present: Parish Councillors Barber, Blessett, Bowell, Dilks (District), Gilbert, Green, Hall, Halls, Hosking, Pelling, Shinkins, Stevens (District), Thomas and Ward.

### Open Forum

The neighbourhood Policing team had visited the office and informed the Clerk of several incidences of criminal damage which had taken place during the month. Most of the cases were still under investigation although one culprit had been spoken to.

County Councillor Dobson had provided a report about LCC matters which had been circulated to the Parish Councillors prior to the meeting

District Councillor Judy Stevens had prepared a report which was circulated to the Parish Councillors and included news about the Literary Festival 2019, changes in Council Tax for young people between 18-22 who are in care, and a meeting at the community centre on 26 June 2018 where there will be a presentation from Officers from culture and visitor economy.

District Councillor Dilks referred to the council meeting last week where the local plan had been considered advising that the Millfield site was not included for development but the land at the north end of Linchfield Road was. Other items that had been considered were District Councillor Baxter's motion that Grantham should have a Town Council (rejected), and that the decision for Invest SK to be a separate Company should have been considered by the Scrutiny Committee prior to Cabinet making the decision. He also advised that the Social Housing obligation on housing developments was changing from up to 35% to a solid 30%. Councillor Dilks ended by advising that District Councillor Helen Goral and Communications Officer Adrian Smith had visited the Deepings on 11 May 2018 and been guided round the area by himself, District Councillors Stevens, Baxter and Neilson to encourage communications and publicity of The Deepings

# 1.19 To elect a Chairman of the Council and receive the Chairman's declaration of Acceptance of Office (or if not received to agree when it shall be received).

Two proposals were received and seconded.

Councillor Bowell accepted the proposal and Councillor Ward declined. It was **RESOLVED** that Councillor Bowell would be the Chairman for a second year. It was agreed that Councillor Bowell would visit the office on Monday 4 June 2018 to sign the declaration of acceptance of office.

### 2.19 To elect a Vice Chairman of the Council and receive the Vice Chairman's Declaration of Acceptance of Office (or if not received to agree when it shall be received).

One proposal was received and seconded.

It was **RESOLVED** that Councillor Ward would be the Vice Chairman for a second year. It was agreed that Councillor Ward would visit the office on Monday 4 June 2018 to sign the declaration of acceptance of office

#### 5.19 To appoint committees and advisory committees.

It was agreed that the committees should remain as they are with the following additions:

Councillor Hardy to become a member of the allotments footpath and open space committee and the planning committee.

Councillor Halls to become a member of the finance and general purposes committee and the planning committee.

It was noted that a staffing sub-committee had been formed in October 2016 which needed to be added to the committee structure.

### 6.19 To appoint representatives to outside bodies.

As Councillor Dilks had requested that his nomination for this position was withdrawn two further proposals were received and seconded for a representative on Deeping St James United Charities. Councillor Bowell declined the proposal. It was **RESOLVED** that Councillor Ward should become the second Parish Council representative on Deeping St James United Charities

It was agreed to remove the Spalding and Peterborough Transport Forum from the list.

### 7.19 To review and re-adopt the Code of Conduct.

It was **RESOLVED** to re-adopt the Code of Conduct.
