The minutes of the meeting of Deeping St James Parish Council held on Thursday 21 December 2017 at 7.30 pm at The Institute. The business to be dealt with at the meeting is listed in the agenda below.

Present: Councillors Barber, Blessett, Bowell, Dilks, Gilbert, Hall, Hardy, Hosking, Pelling, T. Stevens, Ward, Dobson and two members of the public.

The minutes were taken by the Parish Clerk.

### **Open Forum**

Two residents, Emily and Andrew, spoke about road safety issues outside Linchfield community primary School. The School, which has a roll of 400 and two nurseries, is encouraging healthy lifestyles and trying to reduce the number of cars travelling to School so many pupils walk. This along with the 20mph speed signs and the yellow zig zags is all very good but many feel there is a need for an official crossing or the reinstatement of a lollipop warden as the white lined area that is there at present is confusing for both drivers and pedestrians.

County Councillor Dobson clarified that the classrooms that were being built did not mean the School was expanding as these rooms were to replace the mobile classrooms currently on the site. LCC had recently asked him to enquire what issues needed addressing within his area and he felt that this should be pursued if the Parish Council supported it. It was agreed that Councillor Dobson would speak to LCC road safety partnership to investigate the options available and also arrange a site visit. It was also suggested that an article could be included in the newsletter reminding drivers to reduce their speed near the Schools.

Councillor Dobson advised that he was preparing a report about street lighting after being contacted by a resident.

Councillor Dilks advised that half of the street lights in the parish were the responsibility of the District Council not the County Council and the District were now looking at the savings of turning these lights off.

The structure of District Council had changed with the Head of Finance leaving his post and not being replaced by the promotion of the Assistant but by payments being signed off by a 151 Officer from Rutland.

The District Councils recent 3 million purchase of an office block in Lincoln to earn future revenue had led Councillor Dilks question why there had been no public debate about this especially as Council Tax was raised last year to cover provision of services not to purchase a building. It was noted that South Kesteven District Council were not the only local authority to have purchased buildings and the investment should be a good idea if it keeps Council Tax down and raises Business Rates but it must be transparent.

Councillor Dobson and the two residents left the meeting

Work to trees in the Cemetery and at Woody Heights has been completed

A resident contacted informed the office that the street lights along PROW no. 8 (aka Church Walk) were not working – this has been reported to SKDC

A resident provided photographic evidence of a large amount of graffiti on walls and fence panels along PROW no 8 (aka Church Walk)

Damage to the bus timetable on Linchfield Road was reported to Delaines Bus Company

Councillor Jane Hill from Deeping Gate Parish Council has shared a response received from Peterborough City Council regarding damage to the Bridge over the River Welland. Peterborough City Council confirmed that although there is some damage to the stonework it is superficial, all the mortar is intact and the bell bollards are doing their job.

The grant valuing £45,000 towards the costs of the new skatepark was received from WREN on Friday 15 December 2017

The new website is going live from 1 January 2018 and all new information will be added to this one. The old one will be available to look at for 2 years.

The speed cameras have recently been re-sited on their regular 6 weekly rotation. Over the last six weeks Spalding Road showed an average speed of 34MPH and Burchnall Close 28MPH

After being contacted by Councillor Dilks, Lucy Youles, Legal Services Manager at SKDC had confirmed that she would not be acting as Data Protection Officer for any of the local councils within South Kesteven.
