

### Parish Clerk: Julie Fortnum

The minutes of the meeting of Deeping St James Parish Council held on **Thursday 26 October 2017 at 7.30 pm at The Institute.** 

Present: Parish Councillors Barber, Blessett, Bowell, Dilks, Gilbert, Green, Hall, Pelling, Shinkins, J. Stevens (arriving late), Ward and District Councillor Dobson. The minutes were taken by the Assistant Clerk

#### Open Forum

County Councillor Barry Dobson advised that he had met on site with The Welland Footbridge Forum and was supportive of their very interesting project to build a bridge over the river Welland.

Having made investigations with regards to having The Cross Monument cleaned he advised that The Clerk contact The Parish Clerk at Rippingale who has details of a special cleaning team.

The white lines have now been painted on Spalding Road but Cllr Dobson asked if The Clerk could provide him with more information on location, for him to be able to chase the re-painting of the red cycle path.

A Highways Cluster meeting is to be held on 2 November 2017 at 5.30pm at The Methodist Chapel, Thurlby. Councillors Pelling and Bowell agreed to attend.

Finally Cllr Dobson advised that 2018 will be the Anniversary of The Mayflower from Boston and to celebrate this, events will be held in the town together with a project of joining waterways throughout Lincolnshire.

Councillor Dobson left the meeting.

District Councillor Phil Dilks discussed the recent SKDC summit held at Stoke Rochford where the new leaders committed to investing in the local area with a second Eventus Centre and a new Leisure Centre for The Deepings. It is important that DSJPC are involved in decisions made on the location of the new leisure centre and Councillor Bowell agreed to arrange a meeting with Market Deeping Town Council to discuss forming a 'Leisure Centre' group. (Agenda item Nov)

# 61.18 To approve the minutes of the previous meeting held on Thursday 28 September 2017.

Proposed by Councillor Dilks, seconded by Councillor Pelling and Resolved. The Chairman Signed the minutes.

#### 62.18 Clerks Report

The Parish Council has become aware of a Lorry over the weight restriction crossing the Bridge into Deeping St James from Deeping Gate. The Clerk has contacted the Company concerned requesting it does not happen again and received reassurances that it will not and contacted Peterborough City Council regarding improved signage on the A15 and B1162 Residents have reported increased dog fouling and overgrown weeds on the link footpaths around Linchfield School and into Swift Close and on Church Walk. These areas have been added to the list of grot spots to be tackled by the CPT and the Parish Council's Maintenance Worker will renew the no dog fouling signs.

A resident has approached the Parish Council suggesting that a better location for a defibrillator than Stowgate Road would be on the playing field where it would be accessible to a variety of sporting clubs using the field and astro-turf as well as during community events held on there Councillor Stuart Wallis has handed in his resignation with effect from Thursday 19 October 2017 and the announcement has been placed on the noticeboard giving the electors until 8 November 2017 to call a byelection

The grass area near Panton Close which is the responsibility of SKDC has not been cut this financial year; the Clerk has reported it to SKDC. The Clerk met with Glendale's leading hand on Tuesday 17 October to agree where to plant the 500 crocuses they are providing to replace the ones they mowed over last year

Shaws Coaches have contacted the Council offices requesting that the information on the webpage is updated. This has been forwarded to Councillor Barber to deal with

The Friends of Jubilee Park Bags of Help application which the Parish Council helped to complete has been approved and will be in local Tesco stores from November

Concerns raised about a tree on the boundary of a property in Frognall has been referred to Welland and Deeping Internal Drainage Board The road markings have been replaced on Horsegate and Spalding Road and Councillor Gilbert has requested that the Clerk contacts LCC Highways to collect the road sign

LCC Highways have replaced the broken kerb edging on Rycroft Avenue and have confirmed that they would not approve the placing of a bollard and or a planter in the vicinity to avoid reoccurrence.

A future resident has visited the office asking if work can be done on the trees on the boundary of the property he is about to purchase which backs onto the Cemetery. The Community Pay back will hopefully be doing some work

The Clerk to Deeping Gate has contacted DSJPC as the surface of the footbridge over the River Welland is damaged and a trip hazard – as it is not DSJPC's The Clerk has referred this to PCC and LCC Highways to confirm responsibility.

A resident has contacted the office to advise that the railings near the Plane Tree in the Cemetery are broken and a possible hazard. The Maintenance Worker is to look at this and remove, repair or recommend replacement.

On Thursday 19 October the Clerk and Councillor Barber met with the Grounds Maintenance contractor to discuss the work that had been done at the Riverbank Woody heights and the Cemeteries over the past year. Councillor Barber informed the Full Council that there is to be a change to the contract previously agreed with Glendale and weed control will now be undertaken by a contractor used also by Glendale. DSJPC will go directly to this contractor rather than through Glendale to save on costs. The Community Payback Team has visited the Parish regularly and the Chairman thanked Councillor Barber for arranging this, saying he had received thanks from the public.

Councillor Ward informed the committee that in 2018 £10,000 will be put in the budget towards The Welland Footbridge project. The committee agreed that the revised Risk Management documents should be adopted. Councillor Barber will attend a refresher Website training course during November along with the clerk and assistant clerk.

It was agreed that the maintenance worker will increase his working hours from 18 to 25 hours per week from a start date of 1 April 2018.

2. To agree a donation to The Royal British Legion Poppy Appeal 2018 under LGA 1972 s. 137

Councillor Gilbert proposed and Councillor Hall seconded that a donation of  $\pounds 250.00$  be made. This was agreed by all with Councillor Dilks abstaining.

3. **To approve accounts for payment –** Councillor Shinkins proposed seconded by Councillor Dilks that payments totalling £70,248.14 should be paid. **Resolved** with three abstentions (Councillors Pelling, Barber and Ward)
