Minutes of the meeting of Deeping St James Parish Council held on **Thursday 25 January 2018** at **7.30 pm at The Institute**

Open Forum

Councillor Dobson for Lincolnshire County Council

Representatives from LCC Highways have agreed to visit The Deepings where they will be taken to the sites that have highway issues.

The Head of LCC Highways has confirmed that a further recruitment drive will take place for a crossing patrol person outside Linchfield Road. This position has never been made redundant however recruitment has been challenging.

LCC have not been greatly affected by the news about Carillion, and nothing impacts directly on Deeping St James. The Lincoln bypass materials were all in place and have been paid for so LCC were liaising with the Contractors used by Carillion to get the work done directly.

Councillor Dobson left the meeting.

Councillors Dilks and Stevens for South Kesteven District Council

The First Council meeting of 2018 was held today - the main item being preparation for the 2018/19 budget. This was an ambitious budget requiring various departments making cash savings. Some items included in the budget papers were:

Increasing parking charges in Grantham

Saving on consultancy fees

Offering (in partnership) a commercial waste and food waste service

Building new council houses

Introducing more local markets

The consultation on the budget would close on Monday 29 January 2018 and offered the following three options

- •To increase our element of council tax by £5 for the year (based on a band D property)
- •To increase our element of council tax by 3% (which equates to £4.46)
- •Not to increase our element of council tax

Linchfield School have confirmed that they are interested in running the playscheme in the summer. A proposal will provided to be considered at the youth committee meeting on Thursday 8th February 2018 Potholes on Bridge Street Linchfield Road and Hall Meadow Road reported to Lincolnshire County Council

Street lights not working on Linchfield Road and Buttercup Court reported to Lincolnshire County Council

Cars causing an obstruction/hazard by parking on the bus stop outside Benedict Court have been reported to the neighbourhood policing team.

Two trees in the Cemetery were reported as fallen after the high winds through night on 17 January 2018. A planning application is being prepared for work to be carried out on the remaining trees in the conservation area as a matter of urgency.

The high winds through night on Wednesday 17 January 2018 damaged branches on several trees have been damaged at 'Woody Heights' skatepark. These had work completed on them within the last month. A contractor has been contacted to clear the debris.

The launch of DSJPC's new WEB site took place on 1st Jan 2018. On Wednesday 10th January 2018 Cllr Barber carried out a 2 hour training session with the Clerks on how to update the new Web Site themselves.

105.18 To consider planning matters

1. To receive and consider minutes and recommendations of the planning and transport committee meeting held on Thursday 18 January 2018 – Councillor Barber introduced the minutes from which there were two recommendations.

Planning application \$17/2466 from London & Economic

Planning application S17/2466 from London & Economic Properties/Deeping St James United Charities. Residential development of up to 145 dwellings with primary access of Linchfield Road and secondary access of Burchnall Close with associated open space, car parking and landscaping (outline with matter of access included for consideration). Concerns were raised about density and the number of affordable units. It was agreed to approve the outline permission with the following comment – DSJPC are disappointed at the number of units, a 100 would be more desirable. **RESOLVED** with 3 abstentions

Planning application S17/2300 from Mr Cross 8A Bridge Street Deeping St James. Councillor Barber confirmed that he had spoken to SKDC planning department and clarified the boundary issue so suggested that the following proposal from the committee was sent - DSJPC has no objections to this application however they do request that permission is granted on the condition that the conversion will be an annexe to the property and NOT a separate dwelling and that it will NOT convert to a separate dwelling at any time in the future. **RESOLVED** with 2 abstentions

To receive and consider minutes and recommendations of committees, reports from advisory committees, members reports from external bodies, members reports of meetings, seminars, training and events attended on the Council's behalf:

- Carols in the Park Attended by Councillors Bowell, Green, Hall, Shinkins, J.Stevens and Ward on Friday 22 December 2017. Councillor J Stevens advised that the Mulled Wine and chocolates were well received as were the Salvation Army Band and the Donkey rides and the largest collection to date was made which will be split between Friends of Jubilee Park and The Salvation Army.
- 2. Councillor Surgery attended by Councillors Stevens and Dobson on Saturday 6 January 2018 who had several visitors

- whose main issues related to the state of the footpaths and the potholes in the roads.
- 3. Meeting between Deeping St James Parish Council (Councillor Barber and the Parish Clerk) and Market Deeping Town Council (Councillor Shelton and the Town Clerk) regarding grass cutting and gutter weed spraying from March 2018 attended on Tuesday 9 January 2018 Lincolnshire County Council are unable to confirm if and how many times they will carry out the safety grass cuts and gutter weed sprays across the County during 2018/19 until after the budget has been finalised at the end of February 2018. This means that the signing of the contract with the MDTC/DSJPC's preferred contractor for gutter weed spraying has been put on hold until the decision is received. The amenity grass cuts will no longer be carried out by LCC however the preferred contractor for this job has delayed signing a contract with MDTC/DSJPC until further information is received from both SKDC and LCC
- 4. Events and communications committee held on Thursday 11 January 2018 – Councillor Stevens referred the Members to the minutes from which there were three recommendations and one update:

Refreshments are to be provided at The Institute after the MP John Hayes has dug the first piece of turf to commence the rebuilding of the signal box, at 11.30am on Saturday 10 March 2018 and it was proposed that DSJPC meet the cost for these. **RESOLVED**

The committee also proposed that a Heritage walk around the old part of Deeping St James and tour of Priory Church be held on either Sunday 9 or 16 September 2018. **RESOLVED**

The committee proposed that a '1st World War Music Hall' evening be held on Saturday 10 November 2018 in The Deepings School Hall. This would hopefully be self- funding as it would be a ticket event with those who attend bringing their own food and drink to enjoy whilst watching performances from various drama and dance groups. **RESOLVED**

Councillor Bowell confirmed that Janet Wickens the Regional Development Officer from The Woodland Trust was available to give a talk and present the making a difference awards at this year's annual parish meeting on Tuesday 8 May 2018. All the Members agreed that this was a good idea and linked with the Parish Council's recent the signing of the Tree Charter and the new Tree of the year competition

 Allotments footpaths and open spaces committee held on Thursday 18 January 2018 – Councillor Ward referred the members to the minutes from which there were no recommendations

108.18 To consider a funding request relating to the Welland Footbridge

In the absence of Councillor Blessett the Clerk referred the Members to the documents provided by Sally Jackson from the Northern Footpath Forum explaining that tree work was required prior to the completion of the survey work to obtain Environment Agency consent to continue with the project. Failure to complete this work before the end of February (the start of the nesting season) would delay the project for at least a further 12 months. Whilst the NFF have some funding which they will donate to the Parish Council to offset against the costs it is not sufficient to cover all the work required to obtain this consent and therefore they are requesting that the Parish Council finance the

difference. The Clerk confirmed that £5000 had previously been earmarked for projects such as this and that the Council had committed to budget a further £10000 within the next financial year towards the footbridge project. Councillor Barber proposed that as upon completion the footbridge would become an asset of the Parish Council financial support should be given providing the NFF funds are obtained first and that all invoices are issued in the name of DSJPC. This was seconded by Councillor Shinkins and **RESOLVED.**

109.18 To consider litter enforcement action

Councillor Pelling referred to the information provided by Councillor Stevens regarding the proposal within SKDC's 2018/19 budget papers that they intended to employ the services of two litter/dog enforcement wardens for the District which added weight to his proposal that a deterrent was needed to support the educational approach of the Parish Council took. He then posed the question could the parish council fund the litter warden for a number of days per year so that we were assured they were covering our parish? It was agreed that Councillor Stevens would investigate the costings of this and that the inclusion of Councillor Pelling's article in the newsletter regarding enforcement action would be postponed until this information was obtained but an article would be put together providing parishioners with information about how much it costs to collect and dispose of the litter found within the parish.
